Exclusive of training cost (venue, food and accommodation of participants), materials shall be provided by BAI as template in production of handouts **Health Condition**

Animals should have updated vaccination against Newcastle Disease (ND). In the event that the animals are not vaccinated, they shall be tested at the same time during the sample collection that will be conducted for High Pathogenecity Avian Influenza (HPAI). The animals shall also be accompanied with a Veterinary Health Certificate (VHC) signed by duly licensed Veterinarian concurred by the LGU.

Animal Selection and Inspection

- The Contractor shall provide at least 120% animals for inspection at least 15 days prior to selection. The source farm within the locality /province shall be inspected and assessed by the BAI selection team if the site is suitable for animal quarantine. Compliance with quarantine site requirement shall be followed (attach checklist requirements)
- After selection of animals, BAI shall provide and place customized metal leg bands to each individual animal for proper


