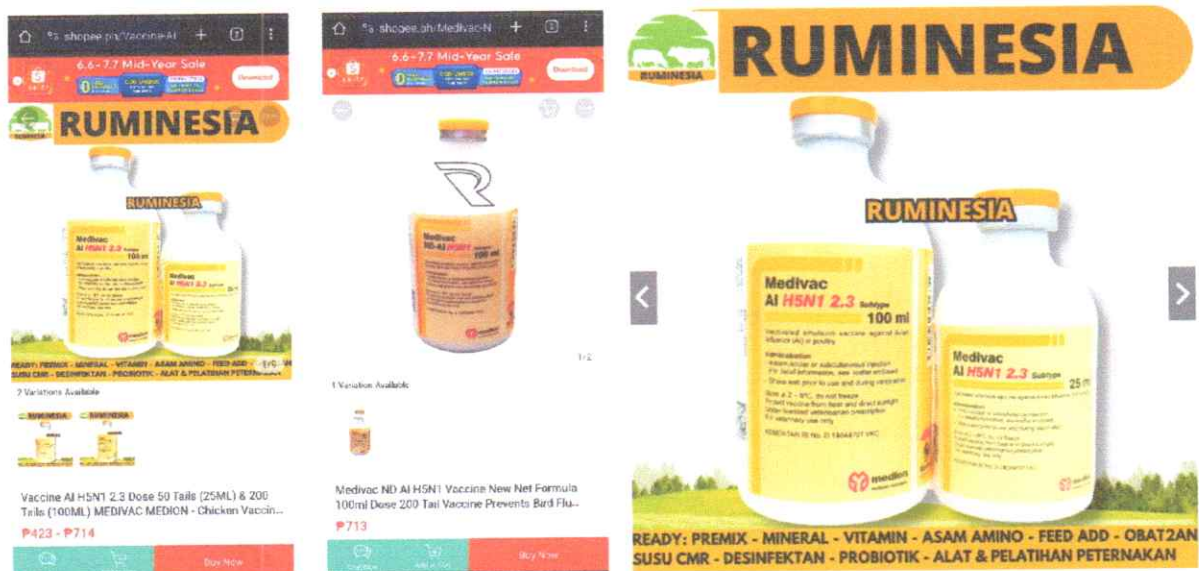

SUBJECT : PUBLIC ADVISORY AGAINST UNAUTHORIZED SALE AND USE OF AVIAN INFLUENZA VACCINES IN THE PHILIPPINES

The Bureau of Animal Industry (BAI) hereby advise the public against **UNAUTHORIZED SALE AND USE of AVIAN INFLUENZA VACCINE**. (See the picture below)
