#### MEMORANDUM CIRCULAR

No. 28

SUBJECT: CONDUCT OF PILOT SURVEILLANCE ON SALMONELLA IN LAYER FARMS IN

CALABARZON AND CENTRAL LUZON ON JUNE - DECEMBER 2023

WHEREAS, Pursuant to the Republic Act (RA) 3639, the Bureau of Animal Industry (BAI) was created on January 1, 1930 to investigate, study and report the cause of dangerous communicable diseases and the means of prevention, and in general, to promote the development of the livestock industries;

WHEREAS, the Bureau of Animal Industry (BAI) is mandated by the Republic Act (RA) 8485 otherwise known as the "Animal Welfare of 1998" as amended by RA 10631, its Revised Implementing Rules and Regulation to protect and promote the welfare of all animals in the country. Administrative Circular No. 12 Series of 2003 provides the practice and minimum standards for the welfare of chickens;

WHEREAS, Republic Act 10611, also known as the Food Safety Act of 2013, was created to protect and promote the right to health of the people by maintaining a farm to fork food safety regulatory system that ensures a high level of food safety, among others. Pursuant to this, the Department of Agriculture through the Bureau of Animal Industry (BAI) is assigned to be the food safety regulatory agency for food derived from animals, including eggs and honey;

WHEREAS, as defined by Executive Order No. 292 s. 1987, the Bureau of Animal Industry is tasked to formulate programs for the prevention, control and eradication of animal diseases and for the development and expansion of the livestock and poultry industries to meet the growing requirement of the growing populace;

Now, therefore, the Bureau of Animal Industry shall conduct a "Pilot Surveillance on Salmonella in Layer Farms in CALABARZON and Central Luzon on June - December 2023" as part of Phase 2 of the Poultry Salmonella Control Program.

#### ARTICLE I

### SURVEILLANCE PLAN

Personnel from the Animal Health and Welfare Division (AHWD) and/or Veterinary Quarantine Station (VQS) 3 and 4A will assist farms in answering the survey questionnaire and will just receive the samples (eggs, dust and feces). They will not enter the premises of the farms in consideration to biosecurity measures against avian influenza. Sample collection will be done every Wednesday. This will be done twice within the period of surveillance.
