MEMORANDUM CIRCULAR

SUBJECT

FOOD AND DRUG ADMINISTRATION (FDA) CLARIFICATION ON THE VALIDITY AND RENEWAL OF LICENSE TO OPERATE (LTO) AND

CERTIFICATE OF PRODUCT REGISTRATION (CPR)

WHEREAS, businesses undergoing renewal processes with the Food and Drug Administration (FDA) have expressed concerns about the requirement to present valid Licenses to Operate (LTO) or Certificates of Product Registration (CPR) for applications related to movement of commodities.

WHEREAS, the Bureau of Animal Industry (BAI) has requested clarifications from the FDA regarding the concerns surrounding the validity and renewal of authorizations for LTO and CPR.

WHEREAS, in a letter dated 23 September 2024, the FDA responded and has clarified the stipulations of Circular no. 2011-004 regarding the validity of the LTO or CPR. According to the clarification, LTOs or CPRs will remain valid and existing until the FDA renders a decision or resolution on the application for renewal. However, it is required to present a 'Proof of Renewal application' to maintain this provision.

IN LIGHT OF THE ABOVE, the following documents can be presented by the clients to this as proof of renewal of application:

For Food Manufacturers – Case number of application AND Official Receipt	All Food Products – Screenshot of case number of application undergoing pre-assessment, OR Screenshot of case
For Food Distributor / Trader - Screenshot of case number of application undergoing pre-assessment, OR Screenshot of case number of application undergoing Payment Verification or Evaluation with Official Receipt	number of application undergoing Payment Verification or Evaluation with Official Receipt

This refers to your inquiry on the provisions of FDA Circular 2011-004 on the validity and renewal of authorizations issued by this Office, specifically:

"For applications for renewal filed within one hundred twenty (120) days from its original expiry, the License to Operate (LTO) or Certificate of Product Registration (CPR) shall be considered valid and existing until a decision or resolution by the FDA is rendered on the application for renewal."

As stipulated in the aforementioned issuance, the License to Operate (LTO) or Certificate of Product Registration (CPR) shall be considered valid and existing until a decision or resolution by the FDA is rendered on the application for renewal. Proof of renewal application is required to maintain this provision.
