BAC RESOLUTION RECOMMENDING FOR AWARD

Resolution No. 22-410 Series of 2022

WHEREAS, Purchase Request No. FOG NBCRDC III 2022-02-005 for the supply and delivery of High Tensile Barbed Wire for NBCRDC III, Bukidnon was approved in the Annual Procurement Plan CY 2022 for Small Value Procurement:

WHEREAS, RULE XVI - Alternative Methods of Procurement, Section 53.9 Small Value Procurement is procurement of goods, infrastructure and consulting services, where the amount involved does not exceed the threshold prescribed in Annex "H" of 2016 Revised IRR: Provided, that in case of Goods, the procurement does not fall under Shopping in Section 52 of this IRR";

WHEREAS, the request was posted twice in PhilGEPS. The 1st posting was on February 17, 2022 up to February 22, 2022 while the 2nd posting was on March 31, 2022 until its closing date on April 7, 2022 for Small Value Procurement. Reposting of the said request was approved as per Resolution No. 22-227;

WHEREAS, BAC Secretariat requested for assistance from the End-user/Authorized Canvasser to canvass from suppliers of known technical, legal and financial qualification to supply and deliver goods;

WHEREAS, the End-user submitted three (3) bid proposal to the supplier of the above-mentioned request;

WHEREAS, three (3) supplier submitted its bid proposals for the above-mentioned request:

WHEREAS, Abstract of Quotations was prepared and was referred to the Technical Working Group (TWG) and End-user for evaluation;

WHEREAS, the report containing the results of the TWG evaluation is attached and marked hereto as Annex "B" and made an integral part hereof;

WHEREAS, after the review of the aforementioned findings of the TWG, the Committee resolved to adopt the same and recommend the Award of Contract to ANGELES RANCH & LIME SUPPLY as the Lowest Calculated Responsive Bid;

NOW THEREFORE, in view of the foregoing premises, THE COMMITTEE RESOLVES, AS IT IS HEREBY RESOLVED, to recommend to the Head of the Procuring Entity to Award the Contract to ANGELES RANCH & LIME SUPPLY, as the Lowest Calculated Responsive Bid for the above-mentioned request in the amount of Two Hundred Seventy-Four Thousand Four Hundred Fifty Pesos (P 274,450.00) only.
